JURY INFORMATION

Welcome. We are happy you want to market your art with the Falling Rivers Gallery family. Falling Rivers Gallery is part of the outreach program of the Stanly Arts Guild. Guild members in good standing are invited to sell their original art, fine crafts and limited edition prints in the Gallery.

We are excited about bringing Stanly County a commercial forum to showcase the exceptional talent that flows rich and deep in its citizens and surrounding area. Falling Rivers is a vibrant answer to this need.

As a co-op style organization, we can offer artists an excellent sales opportunities with very low overhead cost due in large part to our 100% volunteer staff. Artists are required to volunteer in the gallery a minimum of 8 hours each month. As a volunteer in the gallery on a regular basis, artists can meet, greet, and cultivate ongoing relationships with our art aware buying public – this is clearly a win-win arrangement.

Potential Gallery artists must present 3 or more representative pieces of their work for review by at least 3 members of the Jury Committee prior to being accepted. Each style/medium must be juried prior to placement or sale.

Work will be juried weekly or as needed. All accepted work will be monitored to uphold standards. In the event that standards are not upheld, an artist may be required to re-submit to the jury process or remove work.

The Jury Committee in conjunction with the Gallery Director may deem it necessary to place an artist on a “wait list” for a specific medium based on inventory needs and available space. As space permits to accept more work of the medium in which a wait list exists, all artists on the list will be invited to re-submit work for the jury process.
